INVOICE TERMS



PAYMENT: Terms are net cash within thirty (30) days of shipment, except where specific credit terms have been arranged and agreed to. Invoices not paid within thirty (30) days will have a 1½% per month late charge assessed against any unpaid balance from the due date until the date of payment. Buyer grants to Seller a purchase money security interest in all of the Buyer's right, title and interest in and to any goods or equipment sold hereunder to secure the payment when due by Buyer of the purchase price and the performance by Buyer of its other obligations hereunder. A copy of this agreement may be filed on Seller's behalf with appropriate state authorities at any time after signature by Buyer in order to perfect Seller's security interest.

DELIVERY: Delivery shall be F.O.B. Seller's plant.

RETURNS: No returns will be accepted unless return arrangements satisfactory to Seller have been agree upon prior to the return. All return shipments shall be F.O.B. Seller's plant and all return freight shall be at Buyers' costs, unless otherwise agreed to by Seller.
